### WHAT'S BEEN HAPPENING WITH THE EC TEAM?

#### **PEER-LED PROGRAMS**

The PATH (Peer Assisted Treatment for Hepatitis C) team based at Access Health in St Kilda are continuing to build visibility and trust among the local community. Rob and Caro from Harm Reduction Victoria recently hosted a BBQ and distributed packs for the Christmas/New Year's break. So far the duo have recorded over 150 interactions with people around St Kilda including instances of education and referrals to clinical services.





EC Victoria has also secured funding for a Peer-Led project through the Gilead COMMIT community grants. This model will trial and compare three peer-led support and service navigation interventions that aim to build trust and increase engagement with primary health and harm reduction services and increase hepatitis C (HCV) testing and treatment among people who inject drugs (PWID). Commencing in mid-2020, the peer program will aim to assess:

- How peers embedded in a health services can help support more PWID to get tested and complete DAA treatment
- How roving peers in a local area of a health sevice can help engage new clients and refer them into a health service for HCV testing & care
- How peers can be supported to provide rapid point of care testing and monetory incentives to help PWID progress through the care cascade.

## WHAT'S BEEN HAPPENING WITH THE EC TEAM? EC EXPERIENCE COHORT

The EC Experience project aims to better understand people's experiences of treatment and identify barriers and enablers to taking up DAAs. We are recruiting people with a history of injecting drug use who are at different stages in the hepatitis C care cascade.

As of January 2019, we have recruited 281 people into the study from 4 sites, including:

- 14 who have tested negative in the last year
- 102 people who haven't had a blood test in the last year
- 120 people who have been diagnosed and have not been treated
- 45 people who have started or completed treatment.

In December we also met with HRVic staff and were invited to attend their peer networker meeting to share and discuss our initial findings with the volunteers. This meeting highlighted the need to continue a focused effort to reduce stigma and discrimination and to promote the peer-led information provision.

Finally, this year we are planning to publish preliminary outcomes and will also conduct a qualitative study into the impact of past experiences of stigma on healthcare access.

### REVIEW OF TESTING CAMPAIGN

Kico (one of the EC nurses) is currently working on measuring the costs and impact of the EC World Hepatitis Day testing campaigns, including the number of people who tested, how many started treatment, and the overall cost to deliver the project.

We found the testing campaign results in a cost per person tested of around \$250-\$330. The cost of identifying someone who is PCR positive is around \$930-\$1260 and the cost of intiatiting someone on treatment is around \$2250-\$3100.

These results will inform planning for future testing campaigns. Some key learnings are around needing to consider incentives and/or support for clients to return for their testing results.



### HARM REDUCTION VICTORIA

The final broadsheet from the Peer Insights project run by the Australian Research centre for sex, health and society (ARCSHS) in collaboration with Harm Reduction Victoria, NSW Users and Aids Association, Peer Based Harm Reduction Western Australia has been released. The report includes recommendations on increasing uptake of DAAs among PWID in rural and regional areas.



HRVic also recently held the first whole-program meeting day for the Peer Network Program, bringing all of our volunteers together for training and an update from the Burnet Institute's EC Experience cohort study.

Lastly, HRVic and the Association of Participating Service Users are building on the Reducing Harmful Drug Use Through Peer-led Networks (RHDUPLN). This is a 2-year trial that will develop best-practice processes for employing harm reduction peer workers in mainstream organisations.

### ST VINCENT'S PRISON PROGRAM

In November 2019, the Statewide Hepatitis Program held their annual Study Day at the Australian Catholic University in Melbourne which was attended by 35 corrections health staff from across Victoria. The program included presentations on drug use and stigma from Jane Dicka (Harm Reduction Victoria) and Gabrielle Bennett (Victorian Viral Hepatitis Educator), opioid substitution treatment programs (Dr David Jacka), and Hepatitis Victoria's prisoner peer education program (Neylan Akut). An update on hepatitis C elimination and the importance of prison treatment was also given by Mark Stoové (Burnet Institute).



### CLEARING THE PATH CAMPAIGN

Hepatitis NSW and NUAA are rolling out Clearing the Path - a fresh health promotion campaign targeted to people who inject drugs. This campaign is a precursor to the forthcoming larger campaign later in 2020.







Informed by research conducted in 2019, the campaign will help to promote HCV treatment, reduce HCV-related stigma, and debunk myths around treatment.

#### **UPDATE ON PHARM EC**

The PharmEC project is a randomised controlled trial that will compare point-of-care testing and treatment for hepatitis C by a nurse in pharmacies with standard provision of information only. The target group is people who are currently taking opioid substitution therapy.

Enrollment of pharmacies was completed with the first participants recruited in October. As of January 2020, 96 participants have been recruited (50 from control and 46 from intervention pharmacies) with 9 confirmed HCV positive and commencing treatment.
