

MOBILE IMMUNISATION AND HARM REDUCTION SERVICE (MIHS)

Access Health, in partnership with St Vincent's Hospital Melbourne and the Burnet Institute, have recently commenced a pilot evaluation of an outreach service for at-risk homeless populations across metro Melbourne.

The mobile clinic is providing hepatitis A, hepatitis B and flu immunisations, COVID-19 screening referrals and linkage to other health services via a mobile van staffed by a registered vaccination nurse and a social worker. The program will run for three months.

- From 1 April 2020, authorised Nurse Practitioners can prescribe hepatitis B and hepatitis C treatment under the PBS Highly Specialised Drugs (s100) Program.


